	d. "Dunking" of other swimmers under the water.
	e. Yelling for help when not necessary.
	f. Rough play deemed unsafe by lifeguards.

	tolerated:
	a. Alcoholic beverages must be properly covered with "koozy" or insulated cover.

	c. No beverages of any kind are permitted in the pool or on the pool coping stone area.
	d. The use of foul language within hearing distance of other visitors, especially children, will not b
	tolerated on Waterford Swim and Racquet Club grounds.

	f. Refusal to adhere to requests made by the life guards, pool management or HOA management
	to adhere to the above rules may result in removal from the pool and/or grounds. Repeated offenses
