Codes of Conduct

Please initial each line designating your understanding and acceptance.

1. ☐ **No glass of any kind is permitted inside the pool area for any reason. Failure to comply may result in the immediate and permanent revocation of membership, without refund of membership dues. Additionally, violators will be held responsible for any fines levied due to violation of Kentucky Health Codes, pertaining to governance of public swimming pools.**
2. ☐ Life guard instructions must be followed for the safety of all swimmers and patrons. Repeated disregard of instructions may include suspension of privileges.
3. ☐ Parents are responsible for the conduct of their children, while they are on Waterford Swim and Racquet Club property.
4. ☐ Members are responsible for the behavior of their guests.
5. ☐ To help insure everyone's safety, the following behaviors are deemed unacceptable:
 - a. Running in the pool area.
 - b. Diving into the shallow end of the pool.
 - c. Diving off of the board when someone is in the water directly in front of the diving board.
 - d. "Dunking" of other swimmers under the water.
 - e. Yelling for help when not necessary.
 - f. Rough play deemed unsafe by lifeguards.
6. ☐ The Waterford Swim and Racquet Club is a family oriented facility. In order to make certain everyone, including children, may enjoy the pool and grounds, the following behaviors will not be tolerated:
 - a. Intoxication that results in inappropriate behavior or a safety issue for either the individual or other visitors.
 - b. No beverages of any kind are permitted in the pool or on the pool coping stone area.
 - c. The use of foul language within hearing distance of other visitors, especially children, will not be tolerated on Waterford Swim and Racquet Club grounds.
 - d. Bullying of others.
 - e. Refusal to adhere to requests made by the life guards, pool management or HOA management.
7. ☐ Alcoholic beverages must be properly covered with "koozy" or insulated cover.

Failure to adhere to the above rules may result in removal from the pool and/or grounds. Repeated offenses will result in the loss of membership without refund of paid fees.

Waterford wishes to provide a comfortable, fun, friendly community pool, where members come together to relax and enjoy the facility. It is for these reasons we ask everyone to abide by the code of conduct listed above. Everyone's safety and enjoyment is always foremost in our minds.
