Membership Agreement/Medical Waiver: Pool memberships are non-transferable, and membership fees are non-refundable. Waterford residents must be in good standing with the Waterford HOA to purchase a pool membership. The primary applicant, listed family members, and any guests of the primary applicant or family members shall save and hold harmless Waterford Swim and Racquet Club, Waterford HOA II, Waterford HOA II Board of Directors, Professional Pool Management and its employees, and Adkins Property Management and its employees from and against all liability, claims, and demand on account of personal injuries (including, but not limited to, foregoing workman's compensation and death claims) or property loss or damage of any kind whatsoever, which may arise out of or be in any manner connected with the performance of this contract, regardless of whether such injury, loss, or damage shall be caused by, or claimed to be caused by, the negligence of the members of any of the above named or by any of their agents or representatives.

Rules and Regulations: The undersigned Primary Applicant agrees to conform to and be bound by the Rules and Regulations of the Waterford Swim and Racquet Club, as they may be amended from time to time. By signing below, you acknowledge you have read and understand the rules of the Waterford Swim and Racquet Club. Violation of these rules by the Primary Applicant, listed family members or guests, or allowing the use of passes by people other than those listed above, may result in suspension or revocation of privileges without reimbursement of paid fees.

Waterford Pool Rules and Regulations

ENTRY PROVISIONS

1. The pool will be open for use during the days and times listed on the schedule posted at waterfordlexington.com except in cases of inclement weather, special activities or maintenance. Entering the pool during unscheduled times without prior approval will be considered trespassing.
2. Members must present a valid Waterford pool pass to the lifeguard on duty at the gate on each occasion of entering the pool. Member admittance will not be permitted without a valid pool pass.
3. Members may purchase guest passes at the gate. Guest pass prices are \$5 per day except for Memorial and Labor Days (\$10 per day) and the Fourth of July (\$20 per day). Guests must be accompanied by a member and sign in with the lifeguard on duty on arrival. Members are responsible for the behavior of their guests.
4. Nanny/babysitter passes may be used only when accompanied by the child/children listed on the membership application.
5. Children under the age of 13 must be accompanied by a chaperone 16 or older. This rule will be rigidly enforced. If any doubt occurs as to the child's ability to swim, the lifeguard on duty may require the child to leave and to be accompanied by a parent or guardian on future visits.
6. The wading pool is for use of children five years or younger, who must be accompanied by an adult.
7. Lightning is deemed to have occurred nearby when lightning is seen or thunder is heard by a lifeguard. If uncertain as to whether lightning has occurred, lifeguards will verify using an application such as Weatherbug. Lifeguards will clear the entire pool deck of people for 30 minutes after each occurrence of thunder or lightning. Unsupportiveness and/or failure to promptly comply may be grounds for suspension or termination of pool privileges. For safety reasons, no one may reenter the pool deck to collect belongings during those 30 minutes. The pool management company is authorized to close the pool due to inclement weather conditions.

CODE OF CONDUCT

8. Only one person may be on the diving board at a time. The area in front of the diving board is for diving only. Swimming in front of or underneath the diving board or diving or jumping from the side of the board is not permitted. Divers must swim to the nearest ladder to the right of the diving board (not under the lap lane marker or toward the diving board side wall) to exit the pool. The diving area must be clear before the next diver jumps off the board. Diving into the shallow end of the pool is not permitted.
9. Swim goggles or face masks may not be worn when diving or jumping from the diving board.
10. **Dunking, wrestling, running, towel flipping, bullying, rough play and any other activities deemed unsafe by the lifeguards are not permitted and may result in disciplinary action.** Calling out for help when not necessary will not be tolerated.
11. **Intoxication, belligerent behavior, and any language considered profane, abusive, vulgar, harrassing, demeaning or otherwise inappropriate, whether directed toward other patrons or lifeguards, will not be tolerated and may result in immediate suspension or termination of pool privileges without refund.**
12. No smoking or tobacco is permitted in or around the pool area or on Waterford Swim and Racquet Club grounds. This includes cigarettes, smokeless tobacco, and e-cigs.
13. Towels, paper cups, popsicle sticks, plastic straws, balls other than squishy balls, etc. are not permitted in the pool as they may endanger other swimmers or damage the filtration system.
14. Air-filled flotation devices are not permitted. Noodles and foam-filled life jackets are acceptable. No flotation device may be worn when diving or jumping off the diving board.
15. Willful defacement or destruction of property will result in immediate termination of pool privileges without refund. Members are liable for losses or damages caused by their guests and/or children.

Waterford Pool Rules and Regulations, cont.

16. Members and guests are responsible for cleaning up after themselves by removing all containers, wrappers, spilled food/drink, and other trash from deck tables and the surrounding area that they occupied prior to departure.
17. **Glass bottles or containers are strictly prohibited within the fenced pool area.**
18. **Drinks or food items are not permitted in the pool or on the pool apron.**
19. Pool furniture may not be moved outside of the pool area or placed in the pool.
20. Pets are not allowed in the pool area.
21. Waterford Swim and Racquet Club is not responsible for lost or misplaced items. All personal possessions will be removed from the pool and dressing rooms at the end of each day. Lost items are not the responsibility of lifeguards.
22. Lifeguards are present for YOUR safety. Their instructions must be followed promptly and AT ALL TIMES. Noncompliance, argumentativeness, and other language or actions that disregard or diminish lifeguard authority are grounds for disciplinary action.
23. Members are fully responsible for the conduct of their children and guests.
24. Proper swimming attire (no cutoffs, thongs and non-bathing attire) is required in the pool area.
25. Playing of loud music is prohibited.
26. Casual swimming is permitted in lap lanes except when used by lap swimmers. On arrival, lap swimmers should notify lifeguards to clear the lap lanes.
27. The pool is available for rental, at additional charge, for private events outside normal hours. Rental requests should be communicated to the Property Manager two weeks in advance of the rental date and include the time/date of the rental, number of attendees, estimated average age of attendees, whether alcoholic beverages will be present, and whether there are any special admission instructions. One approved adult chaperone per 10 attendees will be required for teenage and college age parties.
28. These rules and regulations shall be in effect at all times and for all events unless superceded by Board policy or by a Board-approved, event-specific waiver.

Noncompliance may result in disciplinary actions including verbal warning, ejection from the pool, suspension of pool privileges, and termination of pool privileges without refund. The Property Manager, Pool Manager and Home Owners Association Board of Directors are authorized to close the pool should, in their judgement, circumstances warrant and may modify these rules in response to future developments.
